Consulted with security personnel at the Buffalo Chip campground, which hosts over 100,000 visitors during the Sturgis Motorcycle Rally each August. This consultation included developing behavioral baselines for patrons to identify anomalies as flags to prevent potential violent crime before it occurs. Also, this same behavioral baseline/anomaly methodology was used in teaching police officers and teachers how to identify and prevent active shooters in schools.

Led the development and implementation of the FBI National Behavioral Science Research Certificate Program, accredited by the American National Standards Institute (ANSI). This program established standardized research design protocols and methodologies that were rigorous, reliable, valid, and met established research industry standards.

Developed and published the Perpetrator-Motive Research Design (PMRD) methodology and protocols for interviewing incarcerated offenders to understand their motivations and the meaning behind their criminal behavior and develop threat profiles. This approach included determining a specific research problem and questions that pertained to crimes that required an understanding of offender behavior from

their perspective to improve training and investigative operations empirically. This process included an extensive review of existing literature, developing codebooks and protocols, interacting with and interviewing offenders, and producing training guides, reports, and journal articles.

Realigned the relationship with John Jay College of Criminal Justice by establishing the use of doctoral students to conduct dissertation studies on research questions directly related to problems identified in the field. This leveraged the ability of the FBI to lead applied research projects and incorporate the results into empirically based training programs and investigative operations.

Created the Evil Minds Research Museum to assist in better understanding the motivation of various offenders and the meaning behind their behavior. This involved the collection of serial killer and other offender artifacts such as manifestos, paintings, greeting cards, personal letters, and other items that the offenders never anticipated would be studied by law enforcement, which reduced the problem of social desirability and its impact on research.

Developed and published the Behavioral Influence Stairway Model, which became an international standard for training law enforcement negotiators in many U.S. law enforcement agencies and the Hong Kong Police Negotiation Cadre.

Dr. Vecchi also covertly entered Border Patrol checkpoints to install vehicle-tracking devices on government vehicles to assist in collecting evidence against Border Patrol Agents who were allowing illegal drugs into the U.S. via the checkpoints. This required extensive behavioral analysis to identify patterns of behavior so the installation of the trackers would go undetected.
